### RECORD OF PROCEEDINGS

The minutes of the Year-end meeting on December 29, 2020.

## PRESENT WERE JON HOFSTETTER, SCOTT WIDMER, AND TOM GREGORY; AND FISCAL OFFICER ANITA FISHER.

- Jon Hofstetter called the meeting to order at 7:00 p.m.
- A motion to approve the December 8, 2020 regular meeting minutes was made by Jon Hofstetter and seconded by Scott Widmer. Motion carried.
- The Fiscal Officer presented the December 2020 Preliminary Financial Reports. These are preliminary because the
  December bank statement has not been reconciled yet due to the month not being complete. Jon Hofstetter made a
  motion to approve the preliminary financial reports for December 2020 as presented. Scott Widmer seconded. Motion
  carried.
- Payroll vouchers for road employees Kevin Hofstetter and Scott Feltis were signed by the trustees.
- The Fiscal Officer presented the following purchase orders for approval:
   -Jon Hofstetter moved to approve then & now purchase orders #83-2020 through #87-2020 for a total of \$3,370.58 in township expenses. Tom Gregory seconded. Motion carried.
- The Fiscal Officer presented the payment listing for bills to be paid including #199-2020 through #214-2020 and #22282 through #22313 for a total of \$150,393.56. Jon Hofstetter moved to approve the bills to be paid for December 2020 and Scott Widmer seconded. Motion carried. See attached (A).
- The Fiscal officer presented the temporary appropriations resolution for the fiscal year ending December 31, 2021 and discussed the process for preparing the temporary appropriations. Jon Hofstetter moved to approve Resolution 2020-12-29-01 to provide for the current expenses and other expenditures of the township in 2021. Tom Gregory seconded.
   A roll call vote was taken:

Tom Gregory – Yes Motion carried.

Discussion was had regarding the Capital Projects Fund and how much to transfer and upcoming capital expenditures that
the township has. Jon Hofstetter moved to approve Resolution 2020-12-29-02 and transfer \$60,000 out of 2021-910-910.
 Scott Widmer seconded.

Motion carried.

Discussion was had on renewing the Road Improvement Levy. This is a 4-year levy. Jon Hofstetter moved to approve
Resolution 2020-12-29-03 to approve Scott Widmer the point of contact with the Wayne County Prosecutors office
regarding the renewal of our road improvement levy. Tom Gregory seconded.

- Work on Handbook is tabled for now.
- Continued work is being done on the Cares Act Projects. Ron Taylor from Kidron Volunteer Fire Department (KVFD) gave an update on their projects.

- Discussion on the 2021 Fire Contracts was had. We have received the contract from Orrville Fire Department for review. The quality assurance changes for the KVFD and East Wayne Fire District (EWFD) contracts discussed in the prior meeting were reviewed and Jon Hofstetter read the verbiage to potentially be added. Scott Widmer suggested changing "quality assurance" to "constructive feedback". Quality assurance implies action to be taken. Jon Hofstetter's goal with this is to allow the trustees to act upon potential concerns that the residents may have. Additional questions from the Wayne County Prosecutor regarding the contracts were reviewed. The Fire Prevention Officer (FPO) issue was also discussed and the requirements of the Ohio Revised Code (ORC). Jon Hofstetter will update the Matrix with our changes regarding the contracts. After changes are made a draft copy will be sent to the departments.
- · No update on the electrical aggregation.
- Jon Hofstetter provided an update on the ODOT study of US 30. Several other parties have expressed interest in being kept in the loop of what is happening.
- Jon Hofstetter mentioned starting to prepare for next years reorganizational meeting and to be thinking of possible changes.
- Jon Hofstetter made a motion to continue the practice of having the employees pay 20% of Health Insurance, with a pre-tax option. Tom Gregory seconded. Motion carried. Scott Widmer abstained.
- Jon Hofstetter made a motion to continue using the Per Diem method. Scott Widmer seconded. Motion carried.
- Jon Hofstetter made a motion to continue having the township meetings on the 2<sup>nd</sup> Tuesday of the month. Tom Gregory seconded. Motion carried.
- Scott Widmer and Tom Gregory made a motion to adjourn at 8:33 p.m. Jon Hofstetter seconded. Motion carried.
