- The Fiscal Officer presented the November 2020 Financial Reports. Jon Hofstetter made a motion to approve the financial reports for November 2020 as presented. Scott Widmer seconded. Motion carried.
- The Fiscal Officer presented the bank reconciliation from November 2020 for review. Jon Hofstetter made a motion to approve the November 2020 bank statement and reconciliation as presented and Tom Gregory seconded. Motion carried.
- Payroll vouchers for road employees Kevin Hofstetter and Scott Feltis were signed by the trustees.
- Jon Hofstetter made a motion to approve Resolution 2020-12-08-01 to reallocate appropriations from one account to another within the same fund. Scott Widmer seconded. See attached (A).

- The Fiscal Officer presented the payment listing for bills to be paid including #191-2020 through #203-2020 and #22223 through #22281 for a total of \$186,049.15. Jon Hofstetter made a motion to approve the bills to be paid for November 2020 and Scott Widmer seconded. Motion carried. See attached (C).
- The Fiscal Officer presented an updated Fund Balance for December 2020. See attached (D).
- Jon Hofstetter presented the road supervisor reports for November 2020 and made a motion to approve and add to the minutes. Scott Widmer seconded. Motion carried. See attached (E).

- Road supervisor Kevin Hofstetter presented a request to purchase additional stone before the end of the year. After
 discussion Jon Hofstetter made a motion to approve the purchase of 3000 tons of 67 limestone from Lil John's Trucking at a
 price of \$21.10 a ton. Tom Gregory seconded. Motion carried.
- Jon Hofstetter reviewed the East Wayne Fire District (EWFD) run reports for November 2020 and made a motion to add to the minutes. Scott Widmer seconded. Motion carried. See attached (F).
- Work on the Handbook is tabled for now.
- Jon Hofstetter provided an update on the Annexation. We are waiting on the final signed copy from the Village of Dalton.
- Jon Hofstetter provided an update on the Cares Act. Ron Taylor from Kidron Volunteer Fire Department (KVFD) who was present at the meeting gave an update of their projects. Ryan Sprunger from EWFD emailed an update on their projects. Jon Hofstetter moved to approve Resolution 2020-12-08-03 to Amend the Certificate of Estimated Resources for additional Cares Act money received and amend the appropriate revenue and appropriation budgets. Tom Gregory seconded. A roll call vote was taken:

Motion carried.

- Discussion was had regarding the upcoming 2021 Fire Contracts. Tom Gregory provided an update from Orrville Fire Department. Orrville Fire Department (OFD) is planning on increasing their per run call to \$500/call for 2021 and \$550/call for 2022. Jon Hofstetter made a motion to agree to the terms provided by OFD and to also have them attach the map to the contract for coverage area. We will upload the contract once received to the Matrix for Wayne County Prosecutor Barbara Biro for review. Tom Gregory seconded. Motion carried. Discussion was had on the contracts for EWFD and KVFD. It was discussed how it would be paid and whether it would be a flat amount or on a percentage basis. Our intention is to offer 95% of the net funds received, paid out in April and September which is approximately one month after funds received. At the year-end meeting, the balance of the funds received will be disbursed to the departments. Other potential changes in the contract were discussed such as a quality assurance procedure that would allow a township board trustee to attend a joint meeting, as needed and requested by the township board, with the fire departments to discuss possible issues if any. The Fire Prevention Officer (FPO) issue was also addressed. Since we have two districts it would seem reasonable to have an FPO for each district. Jon Hofstetter made a motion to submit the information discussed to Wayne County Prosecutor Barbara Biro to review and write up the contracts. Scott Widmer seconded. Motion carried.
- Discussion was had regarding the balance in the Fire/EMS from the previous levy and what to do with the money remaining. A question was posed for if we need a contract to disburse this remaining money out or not. We will follow the Wayne County Auditor's most recent allocation.
- Jon Hofstetter provided an update on the website and some additional information to add to it. Scott Widmer made a
 motion to authorize Jon Hofstetter to add links to the website for the EWFD, KVFD, and City of Orrville; add maps for the
 fire/EMS response areas; condense existing information; and once approved, add the signed contracts to the website. Tom
 Gregory seconded. Motion carried. Scott Widmer made a motion to authorize Jon Hofstetter to update the road
 department tab on the website. Tom Gregory seconded. Motion carried.
- The storm warning system is tabled for now.
- The Cemetery grant money has been received. Work will be completed in the spring.
- Discussion was had on Electrical Aggregation. Jon Hofstetter reported on information from Trebel Energy Services.
 Reviews read on Trebel Energy Services have been very good. It would be a five-year contract, with no auto renewal. Jon Hofstetter made a motion to approve Resolution 2020-12-08-04 to appoint Tom Gregory as the point of contact regarding the electrical aggregation with the Wayne County Prosecutor's office. Scott Widmer seconded.

- An Arnold Rd. resident contacted a trustee about purchasing a plot in the Arnold Rd. Cemetery. Jon Hofstetter will stop at Reed Records to look for the cemetery plot map.
- Our final year-end regular meeting will be December 29, 2020 at the Township Garage at 7:00 p.m.
- Jon Hofstetter made a motion to adjourn at 9:39 p.m. Scott Widmer seconded. Motion carried.
