The minutes of the regular meeting on June 9, 2020.

PRESENT WERE JON HOFSTETTER, TOM GREGORY, SCOTT WIDMER; AND FISCAL OFFICER ANITA FISHER.

- Jon Hofstetter called the meeting to order at 7:00 p.m.
- A motion to approve the May 12, 2020 regular meeting minutes was made by Jon Hofstetter and seconded by Scott Widmer.
 Motion carried.
- A motion to approve the May 28, 2020 special meeting minutes was made by Jon Hofstetter and seconded by Tom Gregory.
 Motion carried.
- The Fiscal Officer presented the May 2020 Financial Reports. Jon Hofstetter made a motion to approve the financial reports for May 2020 as presented. Tom Gregory seconded. Motion carried.
- The Fiscal Officer presented the bank reconciliation from May 2020 for review. Jon Hofstetter made a motion to approve the May 2020 bank statement and reconciliation and Scott Widmer seconded. Motion carried.
- Payroll vouchers for road employees Kevin Hofstetter and Scott Feltis were signed by the trustees.
- The Fiscal Officer presented Then and Now Purchase Orders from 50-2020 through 53-2020 for a total of \$21,408.52 for approval.
 Jon Hofstetter moved to approve the Then and Now Purchase Orders and Scott Widmer seconded. Motion carried.
- The Fiscal officer presented the payment listing for bills to be paid including #86-2020 through #100-2020 and #22114 through #22132 for a total of \$44,338.37. Jon Hofstetter moved to approve the bills to be paid for June 2020 and Tom Gregory seconded. Motion carried. See attached (A).
- The Fiscal Officer presented an updated Fund Balance for June 2020. See attached (B).
- Jon Hofstetter presented the road supervisor reports for May 2020. Tom Gregory seconded. Motion carried. See attached (C).
- Jon Hofstetter presented an update on the jobs currently being worked on by the road supervisor.
- Jon Hofstetter reviewed the East Wayne Fire District (EWFD) run reports for May 2020. Jon Hofstetter made the motion to add the report to the meeting minutes and Scott Widmer seconded. Motion carried. See attached (D).
- Tom Gregory gave an update on Kidron Volunteer Fire Department (KVFD) information. The MABAS (Mutual Aid Box Alarm System) changes were reviewed and accepted from KVFD and Scott Widmer moved to add the information to the meeting minutes. See attached (E). Jon Hofstetter seconded. Motion carried. The recommendation for a Fire Prevention Officer (FPO) was received from KVFD and reviewed. Jon Hofstetter moved to approve Resolution 2020-06-09-01 approving Chief Jimmy Zimmerman from Apple Creek Fire Department as interim Fire Prevention Officer for the KVFD response area for the 2020 year. Tom Gregory seconded.

A roll call vote was taken:

Tom Gregory – Yes Motion carried.

Scott Widmer moved to approve Jon Hofstetter as the point of contact with our newly appointed FPO about appointing deputy FPO's for the EWFD response area. Jon Hofstetter seconded. Motion carried. Jon Hofstetter moved to enter the information into the township's meeting minutes. Scott Widmer seconded. Motion carried. See attached (F).

• Jon Hofstetter gave an update on the Proclamation on the Eckard Rd. rescue. Work will continue on this. It was mentioned to be sensitive to the family's wishes regarding this recognition.

- Tom Gregory gave an update on the amount that KVFD wishes to request from a levy from the Southern Fire District in the township. The amount requested is \$100,000, which seems to be in line with the millage we had asked the County Auditor to calculate. Jon Hofstetter made contact with the Wayne County Auditor who has turned it over to the State for approval. We have yet to hear back from them. The Wayne County Prosecutor (WCP) has also been updated on the fact that we want to pursue a two-year levy. Detailed area maps were reviewed regarding the coverage area of the Northern and Southern areas of the township. Jon Hofstetter moved to approve the tentative township divide as supported by the maps and the uploading of the maps to the Matrix. Scott Widmer seconded. Motion carried.
- Jon Hofstetter presented an update on the Township handbook. The WCP is ready for the next items to be uploaded, with the
 understanding that the fire districts and levy work takes precedence.
- Jon Hofstetter presented an update on the annexation project. The WCP has made contact with the Village solicitor. A lot of
 details are yet to be determined before we can move forward. Jon Hofstetter was invited by Dalton Mayor Finley to attend a
 meeting to discuss TIF's (Tax Increment Financing) and JEDDs (Joint Economic Development Districts) and he will keep the board
 informed of any information received.
- Jon Hofstetter presented an update on the website changes. Several pictures were received from photographer Randy Fath who is willing to provide his services free of charge. Tom Gregory moved to approve Randy Fath as the township photographer to update our website. Scott Widmer seconded. Motion carried.
- Jon Hofstetter provided an update on the Armstrong Cable Franchise Fee. We are able to move this fee up to 5%, but can keep it at the current level of 3% as well. No change will be made. This franchise fee is being collected on TV services only.
- Jon Hofstetter reviewed the OTARMA (Ohio Township Association Risk Management Authority) renewal questionnaire that was
 received. Tom Gregory will continue further work on the renewal questionnaire. Tom Gregory will look on the OTARMA website
 for the required Ohio Labor Law posters that need to be updated.
- Jon Hofstetter reviewed information received on the Baer Rd. railroad crossing. Warning devices (flashing lights and stop gates) are to be installed at no cost to the township. PUCO (Public Utilities Commission of Ohio) has ordered Wheeling and Lake Erie to install these by June 3, 2021. Jon Hofstetter will report back next month if additional information is needed.
- Our next regular meeting will be July 14, 2020 at the Kidron Community Center.
- Scott Widmer made a motion to adjourn at 8:24 p.m. Jon Hofstetter seconded. Motion carried.





The Kidron fire department periodically reviews its MABAS boxes. When doing so we try to take into consideration several things such as: updated equipment, available personnel, and not depleting our neighbors' resources so their communities have what they need in case of an emergency. When we updated box 7-2 there were two major things we needed to consider. First, part of box 7-2 is in East Union Township and our contract with them states that Apple Creek FD is to respond to all confirmed structure fires. We moved Apple Creek FD from a fill in engine to an on scene engine to full fill the contract. The second thing we had considered at the time we did the updates was the lack of daytime manpower available to East Wayne. Our thoughts were to request a squad and tanker from East Wayne so they would only need three personnel to respond with those two trucks which would hopefully help them with their limited daytime manpower.
