RECORD OF PROCEEDINGS

The minutes of the regular meeting on May 12, 2020.

PRESENT WERE JON HOFSTETTER, TOM GREGORY, SCOTT WIDMER; AND FISCAL OFFICER ANITA FISHER.

- Jon Hofstetter called the meeting to order at 7:00 p.m.
- A motion to approve April 21, 2020 regular meeting minutes was made by Jon Hofstetter and seconded by Scott Widmer. Motion carried.
- A motion to table the May 6, 2020 special meeting minutes until the next meeting was made by Scott Widmer and seconded by Tom Gregory. Motion carried.
- The Fiscal Officer presented the April 2020 Financial Reports. Jon Hofstetter made a motion to approve the financial reports for April 2020 as presented. Scott Widmer seconded. Motion carried.
- The Fiscal Officer presented the bank reconciliation from April 2020 for review. Jon Hofstetter made a motion to approve the April 2020 bank statement and reconciliation with Tom Gregory seconding. Motion carried.
- Payroll vouchers for road employees Kevin Hofstetter and Scott Feltis were signed by the trustees.
- The Fiscal officer presented the payment listing for bills to be paid including #69-2020 through #81-2020 and #22095 through #22113 for a total of \$33,894.24. Jon Hofstetter moved to approve the bills to be paid for May 2020 and Scott Widmer seconded. Motion carried. See attached (A).
- The Fiscal Officer presented an updated Fund Balance for May 2020. See attached (B).
- The Fiscal Officer presented Resolution 2020-05-12-01 to reallocate funds from one account to another within the same fund, in the amount of \$1,000.00 to allow for OPERS expense. Jon Hofstetter moved to approve the resolution with Scott Widmer seconding. See attached (C).

 A roll call vote was taken.

Jon Hofstetter – Yes Scott Widmer – Yes Tom Gregory -Yes

Motion carried.

- Jon Hofstetter presented the road supervisor reports for April 2020. Jon Hofstetter made a motion to approve the reports. Tom Gregory seconded. Motion carried. See attached (D).
- Jon Hofstetter reviewed the Melway Paving chip and seal bid. Jon Hofstetter has contacted the Wayne County Auditor and as of now the second half collection is scheduled as normal. We could possibly see a 20% decrease though. Jon Hofstetter made a motion to table the discussion until additional numbers are reviewed with the road supervisor Kevin Hofstetter. Scott Widmer seconded. Motion carried. See attached (E).
- Jon Hofstetter reviewed the East Wayne Fire District (EWFD) run reports for April 2020. Jon Hofstetter made the motion to add the report to the meeting minutes and Scott Widmer seconded. Motion carried. See attached (F).
- Tom Gregory gave an update on Kidron Volunteer Fire Department (KVFD) information. He is waiting to hear from KVFD for the Fire Prevention Officer suggestion as well as their MABAS system changes.
- Jon Hofstetter gave an update on the Proclamation on the Eckard Rd. rescue. Work will continue on this.
- We are currently waiting on additional information for creating two fire districts in the township. Some of the questions still to be
 answered are: a dollar amount both fire departments will need; what the names of the districts would be; how would Orrville Fire
 Department be included; how would the Village of Dalton be included; since EWFD is a tax district should they run their own levy;

what millage is fair; what will the most people support; is there time to get all this accomplished in time for the next election; would a "bridge levy" be a way to go; how can we get this right? There seems to be wide support toward splitting the township into two districts, one covering the northern part and one for the southern part. Jon Hofstetter made a motion to open the floor to allow members of the community to talk. Scott Widmer seconded. Motion carried. Several community members spoke. Blake Nussbaum would like to see two fire districts only, with the Village of Dalton being included in the northern district. Dennis Finley mentioned that the vision committee was the first meeting with people being unified. Reunifying the community is important and moving forward is key. He would like to see whatever needs to be happen to move forward for both communities. Additional discussion was had. Jon Hofstetter made a motion to approve Resolution 2020-05-12-02 creating two fire districts, defined by territory using the 911 GIS map. One in the south part of the township and one in the north part. The northern fire district will include the 911 GIS map of the EWFD response area in both the incorporated and unincorporated area of the township. The southern fire district will include the 911 GIS map for the Kidron Volunteer Fire Department response area as well as the City of Orrville Fire Department response area. These districts will be named at a later date. Scott Widmer seconded.

Jon Hofstetter – Yes Scott Widmer – Yes

Tom Gregory – Yes Motion carried.

Scott Widmer moved to approve Jon Hofstetter as point of contact with Wayne County Auditor GIS department to clarify borders of the response areas in Sugar Creek Township. Tom Gregory seconded. Motion carried.

- Jon Hofstetter provided an update on the creation of a township handbook. He has uploaded the information to the Wayne County Prosecutor's office. Legal representation on this is secondary to the fire districts.
- Scott Widmer reported that Attorney Alfred Schrader is willing to take a reduced final payment of \$24,000.00. This will be paid as soon as the General Fund balance allows for it.
- A special meeting will be planned for May 28th to meet with KVFD and EWFD to continue discussion on the Fire Districts.
- Tom Gregory mentioned the good response we received from OTARMA regarding information we needed for renting equipment.
- Our next regular meeting will be June 9, 2020 at the township garage.
- Jon Hofstetter made a motion to adjourn at 9:10 p.m. Scott Widmer seconded. Motion carried.
