- Jon Hofstetter called the meeting to order at 7:21 p.m.
- A motion to approve the August 11, 2020 regular meeting minutes was made by Jon Hofstetter and seconded by Scott Widmer. Motion carried.
- The Fiscal Officer presented the August 2020 Financial Reports. Jon Hofstetter made a motion to approve the financial reports for August 2020 as presented. Tom Gregory seconded. Motion carried.
- The Fiscal Officer presented the bank reconciliation from August 2020 for review. Jon Hofstetter made a motion to approve the August 2020 bank statement and reconciliation and Scott Widmer seconded. Motion carried.
- Payroll vouchers for road employee Kevin Hofstetter were signed by the trustees.
- The Fiscal Officer presented Resolution 2020-09-08-01 to reallocate funds from one account to another within the same fund, in the
 amount of \$50.00 to allow for Tax Collection Fee expense. Jon Hofstetter moved to approve the resolution with Tom Gregory seconding.

The Fiscal Officer presented the following purchase orders for approval:

Purchase Order #56-2020 to Wayne County Auditor for payment to another political subdivision for \$177.68.

Purchase Order #57-2020 to Melway Paving for road maintenance for \$36,787.25.

Purchase Order #58-2020 to Sterling Farm Equipment for new tractor purchase for \$98,568.50.

Purchase Order #59-2020 to Attorney Schrader for final legal fees for \$9,000.00.

Jon Hofstetter moved to approve the above purchase orders and Scott Widmer seconded. Motion carried.

- The Fiscal Officer presented the payment listing for bills to be paid including #140-2020 through #148-2020 and #22170 through #22188 for a total of \$378,702.53. Jon Hofstetter moved to approve the bills to be paid for September 2020 and Scott Widmer seconded. Motion carried. See attached (D).
- The OTARMA insurance renewal was reviewed. Jon Hofstetter made a motion to accept the renewal from OTARMA. Tom Gregory seconded. Motion carried.
- The Fiscal Officer presented an updated Fund Balance for August 2020. See attached (E).

- Jon Hofstetter presented the road supervisor reports for August 2020 and moved to approve. Scott Widmer seconded. Motion carried. See attached (F).
- Jon Hofstetter presented an update on the sale of our old tractor. The Road Supervisor Kevin Hofstetter has provided some information on a hybrid method of sealed bids/open bids for selling it that had been shared with him. The sealed bids would provide some guarantee/commitment that the item would sell as well as the "ticket" to attend the open bid process where bidders could increase their bid if they so desire. Some of the key points to the sale is to publish information two weeks before sale, include information on the internet website, with instructions on how to bid. Questions to be answered are: when will the auction be, what type of auction, minimum price (possibly \$29,500 which is close to trade in value), approve flyer, terms of sale (cashier's check preferred), contact information, down payment required, 48 hours to pay. Jon Hofstetter will contact the Wayne County Prosecutor to ensure all appropriate steps are being taken.
- Jon Hofstetter provided information we received from the State regarding the Bair Road Railroad crossing. The final step is that the road needs to be painted for the railroad crossing. The Wayne County Engineers office is going to paint it for us.
- Jon Hofstetter reviewed the East Wayne Fire District (EWFD) run reports for August 2020 and moved to add to the minutes. Tom Gregory seconded. Motion carried. See attached (G).
- Tom Gregory provided an update on the vision committee. At their recent meeting, Tom reported that they are behind the creation of the two districts and the levies. Input was received from both fire departments supporting the process. The vision committee has possible plans to put a notice in the paper showing support for the levies.
- Jon Hofstetter mentioned that we need to start contract negotiations for the fire departments for the upcoming year. Tom Gregory will
 contact Kidron Volunteer Fire Department. Jon Hofstetter will contact EWFD. Can the Fire Departments discuss how to move forward
 with the Fire Prevention Officer? More will be discussed on this in October.
- Jon Hofstetter gave an update on the Eckard Rd. Proclamation. EWFD will be hosting the State of Ohio Valor award for this call on October 20, 2020. Possible ideas to continue development of would be a thin ice awareness month in memory of the victim.
- Several Matrix items have been closed out. Maybe some additional data is needed on the fire district maps on the website as well as a
 timeline. Township residents should contact the individual fire departments with how the money will be spent that is raised by the
 levies.
- Jon Hofstetter presented an update on the township handbook. Work will continue on this.
- Jon Hofstetter presented an update on the annexation. Some questions are needing to be answered. Wayne County Prosecutor Barbara Biro, had a question on one paragraph of the annexation contract regarding whether the area being annexed into the Village would still be subject to the road and bridge tax/levy. There is some language that is different from our last annexation so we need to check with the Village of Dalton to see if this was the intention of the Village.
- Jon Hofstetter provided an update on the website changes that are currently in process. Some of the changes that we want to do need to be done by the website provider at a cost of \$125.00/hour. Jon Hofstetter will get a quote for the next meeting.
- Jon Hofstetter made contact with the grant writer that EWFD and KVFD has used in the past. There is a potential grant available in 2021 for the Tornado Siren. Work will continue on this.
- Tom Gregory provided information received from Jay Sell on the electrical aggregation. We can accept an agreement for 5.29/kwh or
 continue to wait a bit. Jon Hofstetter has been contacted from another electrical company who would like to provide a quote as well.
- Our next regular meeting will be October 13, 2020 at the Kidron Community Center at 7:00 p.m.
- Scott Widmer made a motion to adjourn at 8:58 p.m. Jon Hofstetter seconded. Motion carried.
